It has been our great pleasure to establish a good relationship with you, and it is also our excitement to announce that pursuant to an intra-group reorganization, with effect on 1 April 2024 (the "**Effective Date**"), the FUJIFILM Leasing (Thailand) Co., Ltd. will be amalgamated and integrated with FUJIFILM Business Innovation (Thailand) Co., Ltd., whereby upon the amalgamation FUJIFILM Leasing (Thailand) Co., Ltd. will cease to be a juristic person by the law, whilst FUJIFILM Business Innovation (Thailand) Co., Ltd. will be the surviving amalgamated company, and commit to continue business operation as usual.


