Thank you very much for using the DocuColor 8000 Digital Press.

This document provides some security measure information for using the DocuColor 8000 Digital Press, which includes a Fiery server running on Windows® XP Embedded OS.

Please check information in this document as well as the instruction manual of this product before using Fiery EXP8000 Color Server.

- DocuColor 8000 Digital Press includes a Fiery color server (Fiery EXP8000 Color Server) provided by EFI, Inc. running on Windows® XP Embedded OS base (Windows® XP Embedded), which is customized by EFI for use with the Fiery color server. Thus the Fiery EXP8000 Color Server may be affected by various kinds of security vulnerability associated with Windows® XP Embedded. Additionally, the Fiery EXP8000 Color Server may be affected by viruses which take advantage of the vulnerability.
- Please understand that Fuji Xerox will ask users to take any necessary security measures such as installing and using vulnerability correction programs by themselves after installation of the product.
- EFI advises that using vulnerability-correction programs provided by Microsoft on Fiery color servers may affect their performance. Therefore, for vulnerability-correction programs, Fuji Xerox asks users to use programs which are approved by EFI and Fuji Xerox for use with Fiery color servers instead of Microsoft® vulnerability-correction programs. Fuji Xerox will keep providing information about the correction programs approved by EFI and Fuji Xerox to users. The information can be obtained from Fuji Xerox's official web site (<http://www.fujixerox.co.jp/>). Please apply any necessary correction programs by following the information on the website.
- EFI and Fuji Xerox authorize the installation of certain anti-virus software, listed below, onto the Fiery EXP8000 Color Server. When installing anti-virus software, please ensure that all automatic functions of the anti-virus software like automatic real time scan, automatic scheduled scan, automatic pattern file update, etc. are disabled as they may interfere with the performance of the Fiery server. Please refer to the relevant anti-virus software manuals for the detailed instructions to invalidate all automatic functionality.
- When executing the virus scan on the Fiery EXP8000 Color Server, the manual virus scan might be required. While the virus scan is being executed, the Fiery EXP8000 Color Server will not be available. EFI and Fuji Xerox recommend that you execute the scan upon confirmation of no user's job in process. As for the anti-virus software listed below, EFI and Fuji Xerox believe that the anti-virus software could be usable on the Fiery EXP8000 Color Server with the Auto-EXEC processing "Invalid". Neither EFI nor Fuji Xerox guarantees that any anti-virus software does not have any defect. And also, neither EFI nor Fuji Xerox tests nor warranties the efficacy of any anti-virus software, including the anti-virus software listed below.
- Guidelines for running anti-virus software:
 - Anti-virus software should only be run when the Fiery Color Server is idle and not receiving jobs. Please disconnect the net connection from the Fiery Color Server (unplug the net cable), and ensure that there is no user's job in process on Command WorkStation® when executing the virus scan with anti-virus software .

- EFI and Fuji Xerox do not support running any anti-virus software on Fiery products in auto-scan mode.
- The anti-virus software version must be the same language version of the Fiery EXP8000 Color Server's operating system.
- The anti-virus software should be used for files coming into the Fiery EXP8000 Color Server outside of the normal print stream, including but not limited to any of the following:
 - Files in removable media (CD-ROM/R/RW, DVD-ROM)
 - Files copied to the Fiery EXP8000 Color Server from a shared network directory
 - All files on the Fiery EXP8000 Color Server
- The anti-virus software should also be configured to scan all files on the Fiery color server when the Fiery color server is not planned for use for an extended period of time.
- In the event of infection, the recommended course of action is to remove the virus by reformatting the HDD and reloading system software.
