Terms & Conditions

- 1) General
 - a) EP-BB system shall be for the following use:
 - i) Automatic retrieval of the meter-readings of the Customer's equipment designated for EP-BB
 - ii) Monitor and manage the replenishment of consumables of the Customer's equipment designated for EP-BB
 - iii) Proactively monitor and respond to technical faults captured by the Customer's equipment designated for EP-BB
 - iv) Generate a Green report that would contain information pertaining to printing usage, impact of usage to the environment and service history of Customer's equipment designated for EP-BB.
 - v) Improve the quality of products and service of FUJIFILM Business Innovation Philippines Corp. (FBPH) to Customer.
 - b) All information gathered from Customer's equipment designated for EP-BB shall be sent via internet to the EP-BB Center. The EP-BB Center is the location of the servers for collecting the relevant information from the Customer's equipment.
 - c) Meter-reading generated from the Customer's equipment via the EP-BB will be the basis for the billing of the click-charges as specified in the contract pertaining to the equipment maintenance of this particular equipment.
 - d) Any device installed by FBPH at the Customer's site for the purpose of activating and maintaining EP-BB shall remain the property of FBPH.
- 2) Customer Responsibility
 - a) Maintain the required connection between the Customer's equipment designated for EP-BB and the EP-BB Center.
 - b) Inform FBPH immediately when changes to the Customer's network settings have been made and the EP-BB connection cannot be restored.
 - c) Update FBPH when any of the contact persons indicated in the front page of this Activation Form have changed.
- 3) FBPH Responsibility
 - a) FBPH shall keep the information in this EP-BB Activation Form confidential and shall use the information for the purpose of:
 - i) Activating EP-BB; and,
 - ii) Communicate with Customer pertaining to all matters related to EP-BB.
 - b) FBPH shall contact the Customer if and when the network communication between Customer's equipment and the EPBB System is blocked or cut for more than Seven (7) calendar days.
 - c) FBPH shall maintain the security features of EP-BB such that:
 - i) The communications via Internet are protected by digital certificates for rigid client authentication;
 - ii) The communications between Customer's equipment and the FUJIFILM EP-BB Center are encrypted with SSL to prevent data wiretap or manipulation. FUJIFILM EP-BB Center will send a certificate to the Customer's equipment to prevent any illegal access; and,
 - iii) Any access of the Customer's equipment from the FUJIFILM EP-BB Center is prohibited. EP-BB relevant system setting information can only be changed by polling, when there is a notification by the Customer's equipment.
 - d) FBPH shall not use nor disclose the information collected for any other purpose except for those which are expressly stated herein.
- 4) EP-BB may be suspended and hence FBPH is unable to obtain information via EP-BB due to the following reasons:
 - a) Equipment has no power or is turned "OFF";
 - b) Network connection/communication is blocked or cut; and/or,
 - c) EP-BB system is temporarily suspended for maintenance or other technical reasons.
- 5) FBPH may amend the terms and conditions of use with prior notification to the Customer.
- 6) FBPH reserves the right to charge the Customer for the provision of any service rendered via EP-BB with One (1) month prior notice and upon mutual agreement.
- 7) Term: The use of EP-BB is co-terminus with the existing contract pertaining to the equipment maintenance of the Customer's equipment that is designated for EP-BB. Either party may terminate the use of EP-BB by giving the other party One (1) month prior written notice, subject to clause (1d).
- 8) The terms and conditions are governed by the laws of the Philippines.
