Admin service	Available	Not available
Company's information retention policy	All information must be kept within the organization only.	Be able to use Cloud Services
Form modification service	Often	Not much has changed
Customization on the program to support other applications such as fill in text message or advertising in the invoice, etc.	Be able to adjust according to Business Requirement	Standard operation Support
Investment budget	Use the budget to invest in Software license and Hardware (Server).	No need to spend money on investment, just charge per transaction

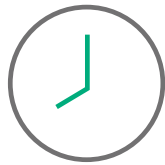

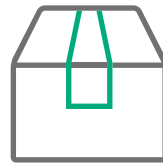
